Dear Business owner/manager,

Enfield Council has secured £30 million from Transport for London to transform the way we move around our Borough. This programme, called Cycle Enfield, will improve many of the borough's high streets and town centres, making them great places to live, work and travel around. Our proposals aim to improve safety and encourage more people to walk and cycle. As we increase the number of people who make local journeys this way, we will relieve congestion, improve air quality and help support the local economy.

A key part of this programme are proposals to re-design both Enfield Town and the road space along Southbury Road from Enfield Town, to the boundary with the London Borough of Waltham Forest.

These proposals also include the re-design of the junction of the A10, Great Cambridge Road with Southbury Road (part of the Transport for London Road network).

### **Benefits of Cycle Enfield**

We believe that the Cycle Enfield proposals will generate the following benefits:

- Improved and safer roads for everyone, however they choose to travel
- Improved facilities will encourage more people to walk and cycle
- Improved public realm will encourage people to spend more time and money in town centres, improved public spaces will create more opportunities for local businesses and community events.

## **How do I find out more?**

Public exhibitions where you can look at these new proposals in detail will be taking place at The Dugdale Centre:

- Business Event – Thursday 24<sup>th</sup> September, 4pm – 8pm
- Public Exhibition – Friday 25<sup>th</sup> September, 3pm – 8pm
- Public Exhibition – Saturday 26<sup>th</sup> September, 10am – 4pm

This will provide an opportunity to discuss the designs. Booking is not required, however, for the business event, there is an opportunity to request a specific time to discuss any issues you may have. Please tell us whether you would prefer a time from 4pm – 6pm or 6pm – 8pm.

## **How can I have my say?**

This exhibition will mark the start of a consultation for the Enfield Town scheme and a separate consultation for the Southbury Road scheme. Each consultation will last for 12 weeks, running from Friday 25th September to Friday 18th December.

Plans will also be on permanent display at the Civic Centre throughout the consultation period. In addition, from Friday 25<sup>th</sup> September you will also be able to request a paper copy of the consultation, including copies of the proposed plans. Copies of the consultation documents will be available on request in accessible formats e.g. large print, Braille and audio.

## **What happens after the consultation?**

Following the consultation process a public report will be produced, the design proposals will be reviewed and, in consultation with Transport for London and taking into account your views, the Council will reach a decision on how to move forward with these schemes during Spring 2016. Following this, construction would be anticipated to start in summer 2016.
